## **2023 Annual Meeting & Nomination of Officials**

The annual meeting will feature a report from the CEO, the board Chair and the Supervisory Committee. We will also conduct an election for three (3) Board positions, each with a term of three (3) years. The names of all nominees will be posted at the SCE FCU Corporate Office by Wednesday, March 15, 2023. The election will not be conducted by ballot and there will be no nominations from the floor when the number of nominees equals the number of positions to be filled. Election results will be announced at the Annual Meeting on Wednesday, April 19, 2023.
